After its IPO, YEO continues to grow rapidly and create new business models. As of November 09, 2021, The DEFIC Globe brand will impact global markets through the partnership of EMSOLT and Yaşar Tuncer, one of the leading energy companies in EMEA countries.

At the pre-launch ceremony held for the company establishment and signing ceremony, YEO Chairman and CEO Tolunay YILDIZ said, "At the point we have reached today, we produce our own projects, and this is the most important point. Our project development activities continue, especially in Europe, mainly Italy and Romania. In fact, we have processes progressing in Italy. Likewise, we are trying to create a portfolio in Romania. Of course, primarily solar, but also wind, biogas, biomass, and, in the future, many others such as hydrogen may be included in the field of activity of this company."

YILDIZ: "Our goal is an organization that produces its own projects."

Yildiz also made the following explanation: "As DEFIC Globe, our aim is to be an organization that produces its own projects, completes them by their construction and offers them to its clients, and even remains as an investor in some of these projects. Therefore, DEFIC may also have a continuous source of income. Time will show such developments. When you look at it, there is no precedent for this. We want to become a structure that supports this with financial processes, while we exist both on the project development side and on the construction side. Good luck to all of us again."

Tuncer: "We are trying to achieve a balanced portfolio for DEFIC!"

Taking the floor after Tolunay Yıldız, Alper, Managing Partner of Emsolt Teknoloji Yatırımları A.Ş. said, "Actually, our work for DEFIC Globe had already started de facto long before. We wanted to crown this de facto process by officializing it on paper. We have been in Italy for about a year. We have an active office and employees there. We personally visit every two weeks and try to achieve a balanced portfolio. When a regional obstacle arises, we try to ensure presence in various locations so that we are not impacted by such obstacle in any way. We have been present in Romania for about six months. We also have an office and employees there. On this occasion, we think that we will move forward with great speed in the projects."

Tuncer continued his words as follows: "As you know, an energy revolution is taking place in Europe. With the Paris Climate Agreement coming into effect, we will be faced with a number of regulations. However, nothing is a coincidence. We are witnessing history and this energy transformation. Italy recently announced 28GW of additional capacity by 2030. Romania is at similar levels. That is why we are in these countries. The process we have started with DEFIC Globe is a team effort, so I have no doubt that we will accomplish important things with this dynamic and strong team."
